#### **OVERVIEW**

## About the Fund

The Saba Closed-End Funds ETF (the "Fund") is an actively managed ETF that seeks to generate high income by investing in closed-end funds trading at a discount to net asset value, and hedging the portfolio's exposure to rising interest rates.

CEFS offers access to Saba Capital's portfolio managers who have years of experience trading and hedging closed-end funds. Saba Capital's investment process includes proprietary screens that dynamically rank closed-end funds across a variety of factors including yield, discount to NAV and guality of underlying securities. CEFS seeks to outperform index-based closed-end fund products by actively trading the portfolio in an attempt to capture the widening and narrowing of discounts to net asset value.

Saba Capital Management, L.P. ("Saba") is a \$5.9bn registered investment adviser founded in 2009 by Boaz Weinstein, who was previously co-head of the Global Credit Trading business at Deutsche Bank, where he managed a team of approximately 650 people and is best known for being on the forefront of utilizing certain credit relative value and capital structure trading strategies. Mr. Weinstein founded Saba in 2009 as a lift-out of Saba Principal Strategies. At Saba, Mr. Weinstein leads a team of 72 professionals, with the senior investment team having worked together for over 10 years.1

The Fund may engage in writing covered call options, which may limit its opportunity to profit from an increase in the price of the underlying stock above the exercise price but continues to bear the risk of a decline in the stock. A liquid market may not exist for options held by the Fund. While the Fund receives premiums for writing the call options, the price it realizes from the exercise of an option could be substantially below a stock's current market price. High-yield bonds have a higher risk of default or other adverse credit events but have the potential to pay higher earnings over investment grade bonds. The higher risk of default, or the inability of the creditor to repay its debt, is the primary reason for the higher interest rates on high yield bonds.

Shares are bought and sold at market price (not NAV) and are not individually redeemed from the Fund. Market price returns are based on the official closing price of an ETF share or, if the official closing price isn't available, the midpoint between the national best bid and national best offer ("NBBO") as of the time the ETF calculates current NAV per share. NAV return is determined using the daily calculated Net Asset Value (NAV).

A portion of the distribution rate may be attributable to return of capital. A return of capital is a return of all or part of a shareholder's original investment in the Fund. A return of capital may occur if the Fund makes distributions in an amount that exceeds the Fund's net investment income and net capital gain.

Exchange Traded Concepts, LLC serves as the investment advisor. Saba Capital Management, L.P. serves as sub advisor to the fund and is responsible for all investment decisions. Foreside Funds Services. LLC serves as the distributor.
