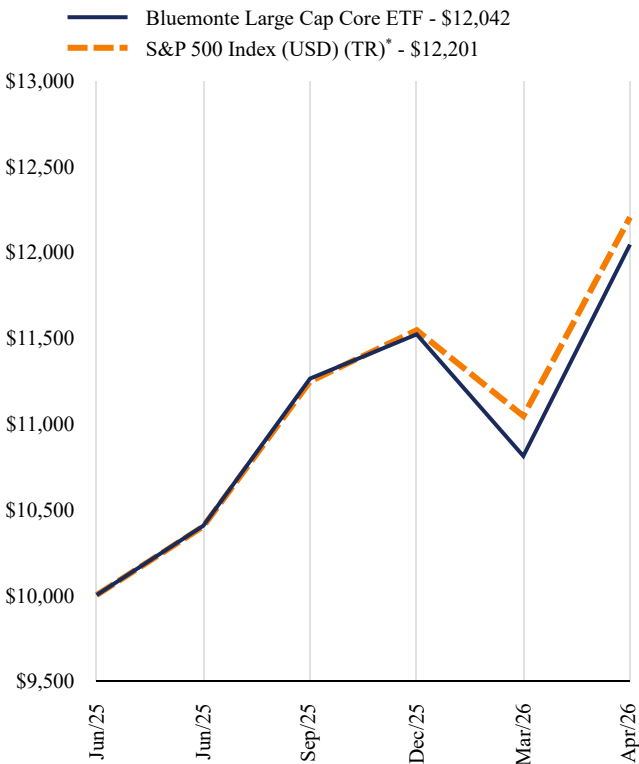
How did the Fund perform in the period?

The Fund seeks to provide capital growth. The Fund had positive performance during the fiscal period ending on April 30, 2026. The Fund achieved a return of 20.42% since its inception on June 20, 2025, while the S&P 500 Index, the Fund's broad-based index, gained 22.01%.

The Fund modestly underperformed the benchmark during the time period due to a combination of factors, including an underweight to the mid-cap space and a slight overweight to growth stocks.

Householding
